Dear Parents/Carers

This year, Garden Suburb School like so many other schools, has suffered extraordinary, unplanned costs, as well as a significant loss of fundraising income due to Covid 19 restrictions and limitations.

Sadly, this term, we haven't been able to run our biggest and most amazing fundraiser, our Seasonal Fair. The Seasonal Fair alone made over £4,000 last year and, together with the other events we were able to run before lockdown happened in March, we had managed to raise just over £9,000 in total.

Thanks to your continued loyalty, support and generosity the PTA were able to purchase some fantastic resources for the children last year, including 6 interactive whiteboards at a cost of £2,500 each. However, we still need to buy 6 more of the whiteboards ensuring that there is one for every class which will cost us £15,000. We were well on our way to this target when lockdown struck.

*We are appealing to you all today to help us raise as much as possible towards our goal so we will be able to equip the classrooms with the whiteboards for our children by donating whatever you can towards our PTA fund.*

As a thank you for all your donations, the PTA will be buying a small, personalised gift for your child which they will receive on the last day of term. The children have coped so amazingly well during these really difficult times and we don't want them to miss out!
